TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "*Assignment*") is made and entered into on September 21, 2015 ("*Effective Date*"), by and between CC Wellness LLC, a California limited liability company ("*Buyer*"), and United Consortium, Inc., a California corporation ("*Seller*") pursuant to that certain Asset Purchase Agreement dated as of September 21, 2015, by and among Buyer, Seller and Solomon Levy, sole shareholder of the Seller (the "*Purchase Agreement*"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Purchase Agreement. Buyer and Seller agree as follows:

1. Trademark Assignment. As of the Effective Date, Seller hereby perpetually, irrevocably and unconditionally assigns, transfers and contributes to Buyer all of its right, title and interest in and to the Trademarks, including all intellectual property rights in the Trademarks, whether such rights are registered or not, and the right to recover for damages and profits and all other remedies for past infringements thereof; and any and all goodwill associated with the Trademarks, including, without limitation, those Trademarks listed on the attached *Exhibit A*.

2. Covenant. Seller shall not use, apply for, or register, or cause or assist any third party to use, apply for, or register, any trademark, service mark, design mark, or any other indicia of source origin that is confusingly similar to any of the Trademarks anywhere in the world.

3. Additional Actions. At any time after the Effective Date, at Buyer's request and expense, Seller will execute and deliver to Buyer such other instruments and documents, and take such other actions as Buyer may reasonably deem necessary or desirable to effect, evidence, record and perfect the transfer and assignment contemplated by this Assignment.


4. Successors and Assigns. This Assignment will be fully binding upon, inure to the benefit of and be enforceable by the parties and their respective successors and assigns.

5. Entire Agreement. This Assignment and the Purchase Agreement, together with the documents referenced herein and therein, and the attached Exhibits constitute the entire agreement, and supersede any and all prior agreements, whether written or oral, with regard to the Trademarks. No amendment, modification or waiver of any of the provisions of this Assignment will be valid unless set forth in a written instrument signed by the party to be bound.



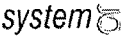
