**TRADEMARK ASSIGNMENT**

2. Assignor agrees that, at Assignee's reasonable written request, Assignor will execute all necessary papers, take all rightful oaths, and do all reasonable acts necessary for vesting title in the Trademark in Assignee, its successors, assigns and legal representatives or nominees.
