PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Partial Release") is made as of September 30, 2015, by BMO Harris Bank, N.A., a national banking association, as Administrative Agent, for the benefit of itself, its successors, assigns and affiliates, the Lenders, as defined below, the Swingline Lender, as defined in the Credit Agreement and the Issuing Lender, as defined in the Credit Agreement referenced below (in such capacity, the "Administrative Agent"), in favor of Landauer, Inc., a Delaware corporation ("Landauer").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 14, 2011 made by Landauer in favor of the Administrative Agent, for the benefit of itself, the Lenders and the L/C Issuer (as heretofore amended, restated, modified or supplemented, and as the same may be further amended, restated, modified or supplemented and in effect from time to time, the "Trademark Agreement"), Landauer granted a security interest in certain of its trademarks and trademark applications to the Administrative Agent to secure certain debt owing from Landauer, Global Physics Solutions, Inc., a Delaware corporation ("GPS") and IZI Medical Products, LLC, a Delaware limited liability company ("IZI", and together with Landauer and GPS, collectively, the "Borrowers" and each a "Borrower"), including without limitation obligations of Borrowers under that certain Amended and Restated Credit Agreement dated as of August 2, 2013 by and among Borrowers, the lenders from time to time party thereto (collectively, the "Lenders") and BMO Harris Bank, N.A., as Administrative Agent, Swingline Lender and Issuing Lender (as heretofore amended, restated, modified or supplemented, and as the same may be further amended, restated, modified or supplemented and in effect from time to time, the "Credit Agreement");

WHEREAS, Borrowers have requested that the Administrative Agent (a) terminate and release the liens and interests of Administrative Agent in certain of Landauer's trademarks and trademark applications hereinafter described and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby releases and terminates its security interests in those certain trademarks and trademark applications described in Exhibit A attached hereto and made a part hereof (collectively, the "Released Trademarks"), and reassigns to Landauer all right, title and interest of the Administrative Agent in and to the Released Trademarks.

NOTICE OF PARTIAL DISCHARGE ONLY: This Partial Release is intended to be only a release and discharge of the Released Trademarks. Administrative Agent's security interest in all other trademarks, trademark applications and other collateral pledged under the Trademark Agreement, and any other Collateral Document, as defined in the Credit Agreement, shall remain. This Partial Release is made and accepted without covenant or warranty, express or implied, at law or in equity, without recourse to the Administrative Agent, in any event or in any contingency.
