Pursuant to Title 8, Section 251 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Anton/Bauer, Inc., a Delaware corporation (the "**Surviving Corporation**"), and the name of the corporation being merged into the Surviving Corporation is Litepanels Inc., a Delaware corporation ("**Panels**").

FOURTH: The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.

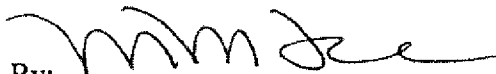
FIFTH: The merger is to become effective as of 12:01 a.m. on January 1, 2014.
