RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Movaris, Inc., a California corporation (the “Company”) entered into that certain Trademark Security Agreement (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time the “Trademark Security Agreement”), dated as of January 4, 2011, with WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company, in its capacity as Agent (the “Secured Party”). NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates and releases its security interest in the Trademark Collateral, including, without limitation, the Trademark Collateral identified on Schedule A attached hereto and assigns and transfers to the Company, without representation, warranty or recourse, all of the Secured Party’s right, title and interest in and to the Trademark Collateral, including, without limitation, the Trademark Collateral identified on Schedule A attached hereto, effective as of the date set forth above.

The Secured Party acknowledges that this document may be filed with the United States Patent and Trademark Office to evidence the termination and release granted herein.

This Release of Security Interest in Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York, without giving effect to any conflict of law principles thereof.
