
Re: Security Agreement Between Central Fiber Corporation and LaSalle Business Credit

We have been advised that certain security interests were granted from Central Fiber Corporation to LaSalle Business Credit, Inc. pursuant to a security agreement dated March 9, 2001. The security interests included trademarks of Central Fiber Corporation. Notice of the security interests relating to Central Fiber Corporation trademarks was recorded with the United States Patent & Trademark Office ("USPTO") and that included notice with respect to trademark application serial no. 76/199,023 (now registration no. 2,534,073) (the "Second Nature Trademark"). Subsequently, a notice was filed with the USPTO acknowledging termination of security interests in the Central Fiber Corporation trademarks but the notice did not include the Second Nature Trademark.

This will confirm the following:

1. Bank of America is the successor of any security interest that would have been granted to LaSalle Business Credit, Inc. from Central Fiber Corporation via the 2001 security agreement.
2. Bank of America holds no current security interest in the Second Nature Trademark.
3. To the extent any security interest still exists, Bank of America hereby terminates, releases and discharges all right, title and interest in the Second Nature Trademark.
4. Bank of America authorizes Kutak Rock LLP to record this document with the USPTO as evidence of termination of the 2001 security agreement.
