Pursuant to Section 18-209 of the Delaware Limited Liability Company Act, the undersigned, Rubble Merger Sub, LLC, a Delaware limited liability company ("*Merger Sub*"), executed this Certificate of Merger for the purpose of effecting a merger (the "*Merger*") of VantaCore Partners LP, a Delaware limited partnership, and VantaCore LLC, a Delaware limited liability company (collectively, the "*Merged Entities*"), with and into Merger Sub, with Merger Sub as the surviving company. Merger Sub hereby certifies, for and on behalf of Merger Sub and for the purpose of merging the Merged Entities with and into Merger Sub, each of the following:

1. The name, jurisdiction of formation and type of entity of each constituent company are as follows:

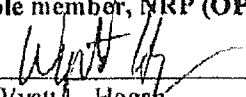
6. A copy of the executed Merger Agreement will be provided, upon written request and without cost, to any member of Merger Sub or member or partner of any of the Merged Entities.
