WHEREAS, Assignor and Assignee desire that the assignment of such Marks be made of record in the United States Patent and Trademark Office; and


WHEREAS, capitalized terms used but not defined herein shall have the meanings respectively ascribed to them in the Asset Purchase Agreement.
