## TRADEMARK ASSIGNMENT AGREEMENT

This *Trademark Assignment Agreement* (the "**Agreement**"), is made and entered into as of August 10, 2015 (the "**Effective Date**"), by and between RealNetworks, Inc., a Washington corporation ("**Assignor**"), and Gaming Realms plc, a company registered in England and Wales with company number 04175777 ("**Assignee**"). Capitalized terms used but not defined in this Assignment will have the same meanings ascribed to such terms in the APA (as defined below).

### RECITALS

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement (the "**APA**") made and entered into as of July 23, 2015, pursuant to which, among other things, Assignor has agreed to sell, assign, transfer, convey and deliver all of Assignor's right, title and interest in, to and under the Transferred Assets to Assignee, which Transferred Assets include right, title and interest throughout the world in and to the trademark registrations and applications identified on Schedule 1 attached hereto and incorporated herein by this reference, and the goodwill of the business symbolized by the trademarks and registrations or applications therefor (collectively, the "**Trademark Rights**").

NOW, THEREFORE, for One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, and in accordance with and subject to this Agreement, Assignor hereby irrevocably sells, transfers, conveys, and assigns to Assignee and Assignee's successors and assigns all of Assignor's right, title, and interest in and to the Trademark Rights, together with any claims, demands, rights of recovery, and causes of action for the past infringement of any of the Trademark Rights.

Assignor also hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and similar officers of states and of foreign countries to issue trademarks, other evidence, and forms of intellectual property protection or applications to Assignee and its successors and assigns in accordance with the terms of this Trademark Assignment Agreement.

Assignor will, at the reasonable request and expense of Assignee, do all things reasonably necessary, proper, or advisable, including without limitation the execution, acknowledgment, and recordation of specific assignments, oaths, declarations, and other documents on a country-by-country basis, to assist Assignee in obtaining, perfecting, sustaining, and/or enforcing the Trademark Rights.

The terms and conditions of this Trademark Assignment Agreement shall inure to the benefit of Assignee, its successors, assigns, and other legal representatives, and shall be binding upon Assignor, its successors, assigns, and other legal representatives.

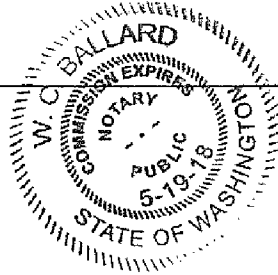
