**SECOND CERTIFICATE OF AMENDMENT

CERTIFICATE OF INCORPORATION

CLOUDBILT, INC., a Delaware corporation (the "Corporation"), hereby certifies:

1. By written consent in lieu of a meeting of the Board of Directors of the Corporation (the "Board"), pursuant to Section 141(f) of the Delaware General Corporation Law (the "DGCL"), resolutions were duly adopted by the Board setting forth a proposed amendment of the Certificate of Incorporation of the Corporation, as amended from time to time (the "Certificate of Incorporation"), declaring the amendment to be advisable and in the best interests of the Corporation, and calling for a vote of the holders of the outstanding shares of Common Stock of the Corporation (the "Stockholders") for consideration thereof. The resolutions setting forth the proposed amendment are as follows:

RESOLVED, that ARTICLE FIRST of the Certificate of Incorporation shall be deleted in its entirety and replaced with:

"FIRST: The name of the corporation (the "Corporation") is MapAnything, Inc."

2. Thereafter, pursuant to resolution of the Board, the Stockholders acted by written consent in lieu of a meeting in accordance Section 228 of the DGCL to approve the amendment set forth above, by which written consent the necessary number of shares as required by statute and the Certificate of Incorporation were voted in favor of the amendment.

3. The amendment set forth above was duly adopted in accordance with Section 242 of the DGCL.
