TO CAMPOFRESCO, CORP.**




WHEREAS, Assignor is desirous of assigning to Assignee all of Assignor's worldwide common law and statutory rights, title, and interest in and to the Marks, along with the goodwill of the business appurtenant to the Marks.



NOW THEREFORE:

Assignment: Assignor hereby assigns, grants, transfers, and otherwise conveys to Assignee all of Assignor's worldwide common law and statutory rights, title, and interest in and to the Marks, including but not limited to (i) all of Assignor's legal, equitable, and beneficial ownership of the Marks, (ii) all of the goodwill of the business appurtenant to the use of the Marks, (iii) those applications and registrations identified on Schedule 1, and (iv) the exclusive right to sue, in Assignee's name and for the sole benefit of Assignee, for any and all past claims or causes of action.
