FIRST LIEN PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of December 1, 2015 (this “**Agreement**”), by and among U.S. CONCRETE, INC. a Delaware corporation (“**U.S. Concrete**”) and REDI-MIX, LLC, a Texas limited liability company (“**Redi-Mix**,” and, together with U.S. Concrete, the “**Grantors**”) and U.S. BANK NATIONAL ASSOCIATION, as the Noteholder Collateral Agent.

Reference is made to (a) the Pledge and Security Agreement, dated as of November 22, 2013 (as amended, supplemented or otherwise modified from time to time, the “**Security Agreement**”), among the Grantors, the other subsidiaries of U.S. Concrete party thereto, and the Noteholder Collateral Agent, and (b) the Indenture, dated as of November 22, 2013 (as amended, supplemented or otherwise modified from time to time, the “**Indenture**”), among U.S. Concrete, as issuer, Redi-Mix and the other subsidiaries of U.S. Concrete party thereto, as subsidiary guarantors, U.S. Bank National Association, as trustee, and the Noteholder Collateral Agent. The Grantors have derived and will derive substantial benefits from the transactions contemplated by the Indenture. Pursuant to the Indenture, the Grantors have agreed to grant a security interest in the Collateral for the benefit of the Holders to secure the payment and performance of the Secured Obligations set forth in the Indenture, subject to the terms of the Intercreditor Agreement, including with respect to the relative rights and priorities in respect of the Collateral.

Accordingly, the parties hereto agree as follows:

SECTION 1.01 **Terms.** Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Indenture or the Security Agreement, as applicable. The rules of construction specified in Section 1.01 of the Security Agreement also apply to this Agreement.

SECTION 1.02 **Grant of Security Interest in the Patent Collateral.** As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantors, pursuant to the Security Agreement, did and hereby do grant to the Noteholder Collateral Agent, its successors and assigns, for the benefit of the Noteholder Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by the Grantors or in which the Grantors now have or at any time in the future may acquire any right, title or interest (collectively, the “**Patent Collateral**”):

(a) all letters patent of the United States or the equivalent thereof in any other country, all registrations and recordings thereof, and all applications for letters patent of the United States or the equivalent thereof in any other country, including registrations, recordings and pending applications in the United States Patent and Trademark Office or any similar offices in any other country, including those listed on Schedule I (the “**Patents**”);

(b) all provisionals, reissues, extensions, continuations, divisions, continuations-in-part, reexaminations or revisions thereof, and the inventions disclosed or claimed therein, including the right to make, use, import and/or sell the inventions disclosed or claimed therein;

(c) all claims for, and rights to sue for, past or future infringements of any of the foregoing; and

(d) all income, royalties, damages and payments now or hereafter due and payable with respect to any of the foregoing, including damages and payments for past or future infringement thereof.

SECTION 1.03 *Grant of Security Interest in the Trademark Collateral.* As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantors, pursuant to the Security Agreement, did and hereby do grant to the Noteholder Collateral Agent, its successors and assigns, for the benefit of the Noteholder Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by the Grantors or in which the Grantors now have or at any time in the future may acquire any right, title or interest (collectively, the "*Trademark Collateral*"):

(a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule II (the "*Trademarks*");

(b) all goodwill associated with or symbolized by the Trademarks;

(c) all claims for, and rights to sue for, past or future infringements of any of the foregoing; and

(d) all income, royalties, damages and payments now or hereafter due and payable with respect to any of the foregoing, including damages and payments for past or future infringement thereof.

SECTION 1.04 *Security Agreement.* The security interests granted to the Noteholder Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Noteholder Collateral Agent pursuant to the Security Agreement. The Grantors hereby acknowledge and affirm that the rights and remedies of the Noteholder Collateral Agent with respect to the Patent Collateral and the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 1.05 *Intercreditor Agreement Governs.* REFERENCE IS MADE TO THE INTERCREDITOR AGREEMENT. NOTWITHSTANDING ANY OTHER PROVISION

CONTAINED HEREIN, THIS AGREEMENT, THE LIENS CREATED HEREBY AND THE RIGHTS, REMEDIES, DUTIES AND OBLIGATIONS PROVIDED FOR HEREIN ARE SUBJECT IN ALL RESPECTS TO THE PROVISIONS OF THE INTERCREDITOR AGREEMENT AND, TO THE EXTENT PROVIDED THEREIN, THE APPLICABLE SENIOR SECURITY DOCUMENTS (AS DEFINED IN THE INTERCREDITOR AGREEMENT). IN THE EVENT OF ANY CONFLICT OR INCONSISTENCY BETWEEN THE PROVISIONS OF THIS AGREEMENT AND THE INTERCREDITOR AGREEMENT, THE PROVISIONS OF THE INTERCREDITOR AGREEMENT SHALL CONTROL.

SECTION 1.06        *Choice of Law.* THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.


