RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 30, 2015, is made by **BANK OF AMERICA, N.A.**, as Agent ("**Agent**"), having an office at 901 Main Street, 11th Floor, Dallas, Texas 75202.

WHEREAS, Agent and Willbros Group, Inc., a Delaware corporation ("**Grantor**"), having its chief executive office and principal place of business at 4400 Post Oak Parkway, Suite 1000, Houston, Texas 77027, are parties to that certain Trademark Security Agreement (the "**Agreement**") dated August 7, 2013, recorded on August 20, 2013, in the United States Patent and Trademark Office commencing at Reel No. 005094, Frame No. 0678, whereby Grantor granted to Agent a security interest in and to the Trademark Collateral (as defined in the Agreement) of Grantor, as identified and/or described in the Agreement;


