RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release"), dated as of December 1, 2015 (the "Effective Date"), is made by Wells Fargo Bank, National Association ("Wells Fargo"), in its capacity as successor-in-interest to Wachovia Bank, N.A. ("Creditor"), in favor of InChem Corp., a North Carolina corporation having its principal place of business at 800 Cel-River Road, Rock Hill, South Carolina 29730 ("Debtor").

WHEREAS, Debtor and Creditor entered into a certain Trademark Security Agreement (the "Security Agreement") dated March 31, 1999, which was recorded with the U.S. Patent and Trademark Office at Reel/Frame No. 1880/0341;

WHEREAS, pursuant to the Security Agreement, Debtor granted to Creditor a security interest in certain collateral including the trademarks listed on Schedule A together with the goodwill associated therewith (the "Trademarks") to secure the payment and performance of certain obligations due from Debtor to Creditor as set forth in a Loan and Security Agreement between the Debtor and Creditor dated as of March 31, 1999 (the "Loan Agreement");

WHEREAS, the Debtor's obligations pursuant to the Loan Agreement have been satisfied;

WHEREAS, Wells Fargo and Creditor merged in 2010, and Wells Fargo is the successor-in-interest to Creditor as a matter of law; and

WHEREAS, Wells Fargo, as Creditor's successor-in-interest, seeks release the Trademarks from the security interest;

NOW THEREFORE, for good and valid consideration, the receipt and sufficiency of which is hereby acknowledged, Wells Fargo hereby agrees as follows:

1. Release. Wells Fargo, as successor to Creditor, hereby releases, discharges, terminates and cancels the Security Agreement any and all security interests granted to Creditor in the Trademarks. If and to the extent that the Creditor acquired any right, title or interest in and to the Trademarks under the Security Agreement, Wells Fargo, as successor to Creditor, hereby returns, transfers and assigns such right, title or interest to the Debtor.

2. Recordation. Wells Fargo hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release created hereby.
