**WHEREAS**, Assignee and Assignor are parties to that certain Asset Purchase Agreement (the "Purchase Agreement") dated on or about the date hereof, pursuant to which the Assignor has conveyed, transferred and assigned and is delivering to Assignee all right, title and interest in and to the Assets (as defined in the Purchase Agreement);

**WHEREAS**, Assignor is the owner of the trademark RED RIVER TRAIL ALE, the associated U.S. trademark registration identified on the attached Exhibit A, and the consumer goodwill associated therewith and symbolized thereby (collectively, the "Mark"); and

**WHEREAS**, under the Purchase Agreement Assignor is required to assign the Mark to Assignee, together with the goodwill associated with the Mark, pursuant to the terms of this Assignment and in a form acceptable for recordation by the U.S. Patent and Trademark Office.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges, Assignor hereby assigns to Assignee all right, title, and interest in and to the Mark together with the goodwill associated with the Mark, any and all registrations and applications for registration of the Mark, and all worldwide rights in the Mark including, without limitation, common law rights based upon use of the Mark. This Assignment includes all rights to damages or profits, due or accrued, arising out of past infringement of the Mark, as well as the right to sue for and recover the same in Assignee's own name.




