**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of December 11, 2015 (this “Release”) is made by Fifth Street Finance Corp., acting in its capacity as administrative agent (in such capacity, the “Agent”) under (i) that certain Trademark Security Agreement, dated as of March 30, 2012 (as amended, supplemented or modified and in effect from time to time, the “2012 Trademark Security Agreement”) between World 50, Inc. (the “Grantor”) and the Agent and (ii) that certain Trademark Security Agreement, dated as of February 28, 2013 (as amended, supplemented or modified and in effect from time to time, the “2013 Trademark Security Agreement” and collectively, with the 2012 Trademark Security Agreement, the “Trademark Security Agreements”) between the Grantor and the Agent.

WHEREAS, pursuant to the Trademark Security Agreements which were recorded at Reel 004749, Frame 0303 on March 30, 2012 and at Reel 004972, Frame 0346 on February 28, 2013, respectively, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A (the “Trademark Collateral”);

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
