## TRADEMARK ASSIGNMENT

WHEREAS, Raw Shorts, Inc., a Delaware corporation ("Raw Shorts"), has adopted and used the mark, "Raw Shorts", in connection with its downloadable computer software and other business activities.

WHEREAS, Antonio Ojalvaro, a Raw Shorts stockholder and CEO is the owner of record of U.S. Trademark Serial No. 86/318118 filed on June 23, 2014, on the Principal Register of the United States Patent and Trademark Office ("USPTO") for the mark "Raw Shorts" in the following International Classes:

International Class 009 for "Downloadable computer software for creating, producing, editing, manipulating, uploading, transferring, downloading, storing, and sharing data, documents, files, information, text, photographs, images, graphics, music, audio, video, and multimedia content with others via global computer networks, mobile telephones, and other communications in the nature of wireless devices."

International Class 035 for "Maintenance of data in computer databases, namely, an online searchable database of licensed digital content for use by others in the creation of customized digital content; uploading and maintaining digital content for others on the internet, namely, updating and maintenance of data in computer databases."

International Class 043 for "Providing a website featuring technology that enables users to create, produce, edit, manipulate, manage, and customize digital content in the nature of videos for use via the internet, television, mobile platforms, digital media, and other platforms; hosting of digital content on the internet; maintenance of online databases for others, namely, maintaining an online searchable database of licensed digital content for use by others in the creation of customized digital content; uploading and maintaining digital content for others on the internet, namely, updating and maintenance of computer software; providing a web-based service, namely, providing a website that gives computer users the ability to create, edit, upload, transfer, download, store, share, manage, and retrieve digital content in the nature of videos; computer programming services, namely,


digital content creation for others; computer graphic design services, namely, creating customizable templates for use by others to create digital content and transferring digital content into usable files that can be used on digital platforms."

WHEREAS, Raw Shorts does own and has acquired Antonio Otalvaro's entire right, title and interest in the Raw Shorts mark, and the registration thereof; and


