
The Assignor is the registered owner of a mark that is registered in the United States Patent and Trademark Office, Registration No. 3862973, registration date October 19, 2010.


The Assignee paid the Assignor good and valuable consideration on 1/6/15, and the Assignee acquired the Assignor's rights in the trademark listed in this agreement.
