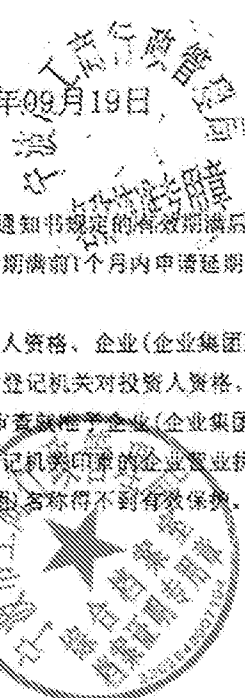

If they are not filed, enterprise (enterprise group) name will not be protected.
4. After name change registration, the enterprise registration authority shall include the original of this notice into the enterprise's archive.
5. The person who is removed from the post of the enterprise's legal representative shall not work as the enterprise's legal representative within three years after the date of removal.
