**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Termination"), is dated as of December 29, 2015 and is made by FIFTH STREET FINANCE CORP., a Delaware corporation, acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") under each of the ITSOL Trademark Security Agreement and AWL Trademark Security Agreement (each as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 26, 2013 made by ITSOL Inc., a California corporation ("ITSOL"), in favor of the Administrative Agent (the "ITSOL Trademark Security Agreement"), ITSOL granted to the Administrative Agent a security interest in all of ITSOL's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A-1 (the "ITSOL Trademark Collateral")

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 26, 2013 made by All Web Leads, Inc., a Delaware corporation ("AWL") in favor of the Administrative Agent (the "AWL Trademark Security Agreement"), AWL granted to the Administrative Agent a security interest in all of AWL's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A-2 (the "AWL Trademark Collateral", and together with the ITSOL Trademark Collateral, the Trademark Collateral);

WHEREAS, the ITSOL Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 27, 2013, at Reel 5162 and Frame 0696;

WHEREAS, the AWL Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 27, 2013, at Reel 5162 and Frame 0747;

WHEREAS, pursuant to that certain Agreement of Merger effective as of December 31, 2015, ITSOL merged with and into AWL, with AWL succeeding as the surviving corporation;

WHEREAS, AWL has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the ITSOL Trademark Security Agreement and the AWL Trademark Security

Agreement and in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral.
