Assignor hereby sells, transfers and assigns to the Assignee, and its successors and assigns, all right, title and interest in and to (a) said trademarks, and registrations and applications thereof, listed on **Schedule A** and any extension or renewal of any such registration or application set forth on **Schedule A** and the ongoing and existing business to which the trademarks pertain; (b) all other indications of origin relating to Assignor's business, including, without limitation, in and to all trademarks, service marks, brand names, trade dress, images and domain names relating to Assignor's business; (c) all goodwill associated with the aforementioned trademarks and indications of source; (d) any unregistered rights in any of the foregoing; (e) all rights to sue and recover damages or obtain injunctive relief for past and future infringement, misappropriation, violation or breach of any of the foregoing; (f) all income, royalties, damages and other payments now and hereafter due or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present and future infringements thereof), and (g) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever accruing thereunder or pertaining thereto.
2. Assignor and Assignee agree that this Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement.
