TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment"), is entered into as of December 28, 2015 (the "Effective Date"), by and between Flint Trading, Inc., a North Carolina Corporation doing business as Ennis-Flint, with a place of business at 115 Todd Court, Thomasville, North Carolina 27360 ("Assignor" or "EF") in favor of Quest Construction Products, LLC, a Delaware limited liability company, with a place of business at 1465 Pipefitter Street, Charleston, South Carolina 29405 ("Assignee" or "Quest"), the purchaser of certain assets of EF pursuant to a Trademark Purchase Agreement, dated December 28, 2015 ("Trademark Purchase Agreement").

1. Assignment. For good and valuable consideration, the receipt and sufficient of which are hereby acknowledged, Assignor irrevocably sells, assigns, transfers and conveys to Assignee, and Assignee accepts, all of Assignor's rights, title, and interest in and to the trademark registrations, applications and all common law rights set forth in Schedule 1 hereto and all issuances, extensions and renewals thereof (the "Marks"), together with the goodwill of the business connected with and symbolized by the Marks.

2. Recordation and Further Action. Assignor authorizes the Commissioner for Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of all rights, title and interest in the registrations and/or applications for registration set forth in Schedule 1 from Assignor to Assignee,

3. Counterparts. This Assignment may be signed in counterparts and each such counterpart shall constitute an original document and such counterparts, taken together, shall constitute one and the same instrument. Facsimile, electronic and other copies will have the same force and effect as the original.

4. Governing Law. This Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of North

Carolina, without giving effect to any choice or conflict of law provision or rule (whether of the State of North Carolina or any other jurisdiction).

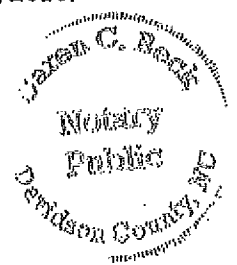

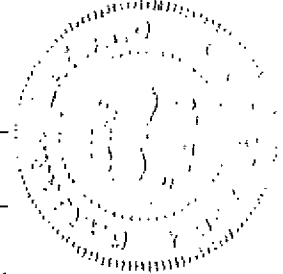
