
RELEASE OF SECURITY INTEREST



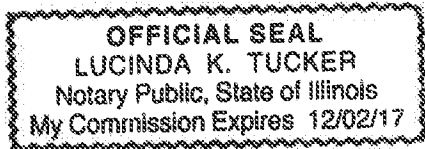

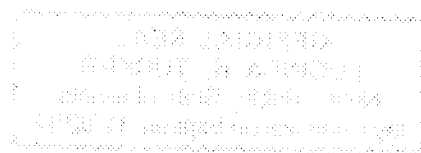
