WHEREAS, the Grantor wishes to obtain a release of the Released Trademarks, and the Secured Party wishes to grant such release.



The Secured Party shall, at the Grantor's expense, take all further actions, and provide to the Grantor, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release.
