## TRADEMARK ASSIGNMENT

- (a) L M ERICSSON has sold, assigned and transferred effective as of an assignment date of 1 December 2013, and otherwise does hereby sell, assign and transfer to the ASSIGNOR, L M ERICSSON's entire right, title, and interest in and to said TRADEMARKS as of 1 December 2013; and
- (b) the said ASSIGNOR has sold, assigned, and transferred effective as of an Assignment Date of 1 December 2013, and does hereby sell, assign, and transfer to the ASSIGNEE, ASSIGNOR's entire right, title, and interest in and to said TRADEMARKS as of 1 December 2013, the same to be held and enjoyed by the ASSIGNEE for its own use and benefit and for the use and benefit of its licensees, successors, assigns or other legal representatives; with the right to sue for infringement and damages and collect the same for its own use and benefit and for the use and benefit of its licensees, successors, assigns, or other legal representatives and further in accordance with the terms of the Trademark Assignment Agreement dated 31 October 2013, which agreement will prevail over this Assignment to the extent of any inconsistency;
