## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of January 28, 2016, by Fifth Third Bank, in its capacity as administrative agent ("Administrative Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreements (as defined below).

### WITNESSETH:

WHEREAS, Ryko Solutions, Inc., a Delaware corporation ("Grantor"), and Administrative Agent are parties to (i) that certain Trademark Security Agreement dated as of July 27, 2012, which was recorded with the United States Patent and Trademark Office on July 27, 2012 at Reel 4830, Frame 0516 (the "2012 Security Agreement"), (ii) that certain Trademark Security Agreement dated as of April 2, 2013, which was recorded with the United States Patent and Trademark Office on April 2, 2013 at Reel 4996, Frame 0001 (the "2013 Security Agreement"), and (iii) that certain Trademark Security Agreement dated as of July 2, 2015, which was recorded with the United States Patent and Trademark Office on July 2, 2015 at Reel 5567, Frame 0672 (the "2015 Security Agreement"; the 2012 Security Agreement, the 2013 Security Agreement and the 2015 Security Agreement are collectively referred to herein as the "Security Agreements"), in each case, pursuant to which Grantor granted to Administrative Agent a security interest in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Administrative Agent, including the Trademark Collateral set forth on Schedule I annexed hereto; and

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):


- (a) all of the Registered Trademarks, all recordings and registrations thereof and applications therefor, all renewals and extensions thereof, all rights corresponding thereto, and all goodwill associated therewith or symbolized thereby; and
- (b) all proceeds of the foregoing, including, without limitation, all general intangibles embodying, incorporating, evidencing or otherwise relating or pertaining to the Registered Trademarks.

2. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in and to the Trademark Collateral.
