TRADEMARK ASSIGNMENT AND RELEASE

WHEREAS, M&T Bank is the record owner under the terms of an assignment dated August 31, 2011 of U.S. trademark registration Nos. 1,622,498 TARA TAPE & Design and 1,665,850 TARATAPE ("The Registrations");

WHEREAS, the original owner of The Registrations, RJM Manufacturing, Inc. did not intend to assign all right, title and interest to the marks to M&T Bank, nor did M&T intend to take all right, title and interest to the marks;

WHEREAS, M&T Bank did not have title to The Registrations at all. Instead, M&T Bank had a security interest in The Registrations;

WHEREAS, the parties agree that the August 31, 2011 assignment was flawed and that M&T Bank did not take title in The Registrations, and merely had a security interest in The Registrations as it did not have title;

WHEREAS, the credit facilities extended by the M&T Bank to RJM Manufacturing, Inc. have all been satisfied and the parties wish to memorialize and confirm the release of the security interest in The Registrations;

WHEREAS, the Parties have agreed that M&T Bank will correct the assignment error and transfer title to The Registrations as of August 31, 2011, to RJM Manufacturing, Inc. along with any other rights that it held, along all right, title, interest, goodwill and business associated with the marks and release the security interest in The Registrations;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, M&T Bank hereby transfers and conveys over to RJM Manufacturing, Inc., effective upon execution, the entire right, title and interest, goodwill and business associated with The Registrations to be held and enjoyed by the RJM Manufacturing, Inc., its successors, assigns and other legal representatives and

further M&T Bank releases all security interest in The Registrations. This assignment shall be binding upon the parties, their successors and/or assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.
