BILL OF CONVEYANCE

TO HAVE AND TO HOLD, the rights, titles and interests in and to the Purchased Assets (excluding the Leases and Assumed Contracts) granted, bargained, sold, assigned, conveyed, transferred, delivered and set over unto the Transferee on November 1, 2015, for its own use and benefit forever.

AND each of the parties hereto shall use commercially reasonable efforts to take, or cause to be taken, all action, and to do, or cause to be done, all things reasonably necessary, proper or advisable under applicable laws and regulations to consummate and make effective the assignment of the Purchased Assets (excluding the Leases and Assumed Contracts) in accordance with this Bill of Conveyance, including, without limitation, the execution of whatever additional documents, of a private or public nature, may be necessary or convenient.

The terms, covenants and agreements herein contained shall bind and inure to the benefit of the respective parties hereto and their respective legal representatives, successors and assigns.

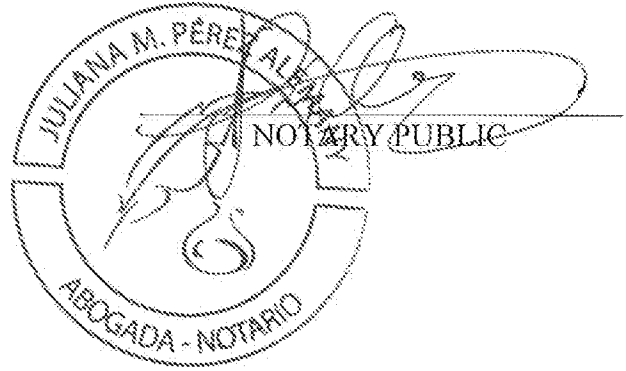
