## TRADEMARK ASSIGNMENT

This Assignment (the "Assignment") is made by Flexo Solutions ("Flexo"), previously identified as a limited liability company.

1. **Assignment of Trademark.** Flexo hereby sells, assigns, transfers and conveys to Hunter Douglas all rights, title and interest in and to the Trademark worldwide, and any applications and registrations therefor, including the registrations identified on the attached Exhibit A, together with the good will associated with the use of and symbolized by the Trademark, to be held and enjoyed by Hunter Douglas as fully and entirely as said interest could have been held and enjoyed by if this sale, assignment and transfer had not been made.
2. **Assignment of Cause of Action.** Flexo further sells, assigns, transfers and conveys to Hunter Douglas the entire right, title and interest in and to any and all causes of action and rights of recovery for past infringement of the Trademark.
3. **Cooperation.** Flexo hereby covenants and agrees to cooperate with Hunter Douglas so that Hunter Douglas may enjoy to the fullest extent the rights, title and interest herein conveyed. Such cooperation shall include prompt execution of all papers prepared at the expense of Hunter Douglas which are deemed necessary or desirable by Hunter Douglas to perfect in it the rights, title and interest herein conveyed.
4. **Warranties of Ownership and Non-Infringement.** Flexo hereby represents that to the best of its knowledge and belief it is the exclusive owner of the Trademark and that no other person, firm, corporation, or association has the right to use the Trademark in commerce, either in identical form or in such near resemblance thereto as to be likely, when used on or in connection with the goods or services of such other person, to cause confusion with the Trademark.
5. **Warranty of No Conflict of Rights.** Flexo hereby warrants and represents that it has not entered into any assignments, contracts, or other understandings with third parties which would conflict with the rights herein granted.





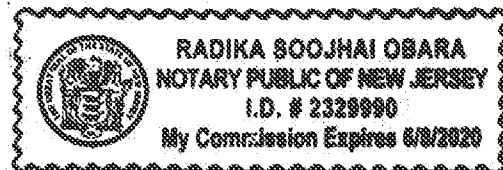
