**ASSIGNMENT OF INTELLECTUAL PROPERTY**

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (this "Assignment") is made and entered into this 31<sup>st</sup> day of DECEMBER, 2015 by and between Patrick G. Dempsey, A California resident, and DEMFINITY LLC, a California limited liability company (collectively, the "Assignor") and JILFINITY AND BEYOND, LLC a California limited liability company (the "Assignee"). Assignor and Assignee may be referred to in this Assignment, individually, as "Party" and, collectively, as "Parties."

**PRELIMINARY STATEMENTS**

WHEREAS, this Assignment is made in connection with the IN RE THE MARRIAGE OF JILL A. DEMPSEY AND PATRICK G. DEMPSEY, CASE NO. BD 614516, SUPERIOR COURT OF THE STATE OF CALIFORNIA, COUNTY OF LOS ANGELES STIPULATED ORDER RE: TRADEMARKS, COPYRIGHTS AND DOMAIN NAMES (the "Stipulated Order"), by and between Assignor and Assignee, dated the \_\_\_\_ day of \_\_\_\_\_, 201\_\_;

WHEREAS, Assignor is the owner of certain intellectual property, including trademarks, service marks, logos, internet domain names, and copyrights, and the goodwill associated with the foregoing, all as set forth Schedule A attached hereto (the "Intellectual Property Assets") and hereby made a part hereof; and

WHEREAS, pursuant to Stipulated Order, Assignor has agreed to assign to Assignee all of its rights, title and interest in and to the Intellectual Property Assets, and Assignee desires to acquire the entire right, title and interest in and to the Intellectual Property;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties mutually agree as follows:

**ASSIGNMENT AND AGREEMENT**

1. Terms and Conditions of Stipulated Order. This Assignment is executed and delivered pursuant to the Stipulated Order and is subject to the terms and conditions thereof. Unless defined herein, any terms defined in the Stipulated Order and used herein shall have the meanings ascribed to them in the Stipulated Order.

2. Assignment. Assignor does hereby assign and transfer to Assignee the entire right, title and interest in and to the Intellectual Property Assets; the same to be held and enjoyed by Assignee for its own use and on its own behalf, and for its legal representatives, successors, assigns and designees, as fully and entirely as the same would have been held by Assignor had this Assignment not been made, for the United States and all foreign countries.

3. Protection and Enforcement. Assignor irrevocably designates and appoints Assignee as its agent and attorney-in-fact, to act for and in its behalf and stead to execute, register and file any such applications, and to do all other lawfully permitted acts to further the registration, prosecution and issuance of patents, trademarks, copyrights or other Intellectual Property Assets with the same legal force and effect as if executed by Assignor. Assignor shall do all acts reasonably necessary to promptly assist Assignee in obtaining, transferring and/or assigning the Intellectual Property Assets, including without limitation, executing such documents as Assignee may reasonably request. To the extent any court, administrative tribunal or agency with appropriate jurisdiction determines any of the rights granted hereunder are inalienable, Assignor agrees not to exercise such rights and this Assignment shall constitute a grant to Assignee the exclusive, perpetual, irrevocable, worldwide,

transferable, assignable, sub-licensable and royalty free right to the Intellectual Property Assets without any obligation of attribution, royalty, or consent. Assignor represents and warrants that it will not take any action that jeopardizes Assignee's rights to the Intellectual Property Assets and will not retain or acquire any right in the Intellectual Property Assets.

4. Miscellaneous. This Assignment shall be binding upon the Parties hereto and their successors, and the terms of the Stipulated Order, including any representations or releases related to the Intellectual Property Assets, are incorporated herein by reference, and shall not be superceded hereby but shall remain in full force and effect to the full extent provided therein. The Parties agree that the Recitals contained herein are specifically incorporated into the Assignment by this reference. The Parties further agree to cause any and all entities or otherwise, which are directly or indirectly controlled or influenced by the Parties, to transfer the Intellectual Property Assets.
