Salus Capital Partners LLC ("Salus") is a successor lender to Wells Fargo Capital Finance Corporation Canada (formerly Wachovia Capital Finance Corporation (Canada) and Congress Financial Corporation) ("Wells Fargo") pursuant to an Assignment Agreement dated January 29, 2013, among Salus and Wells Fargo.

RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, each of Northern Reflections Ltd./Refllet Boreal Ltee (formerly Northern Group Retail Limited) a corporation incorporated under the laws of the Province of Nova Scotia and Northern Reflections U.S. Inc. (formerly Northern Group Retail U.S. Inc.) a corporation incorporated under the laws of the State of Delaware (collectively the "Debtors"), are the owners of the intellectual property set forth in Exhibit A and Exhibit B, as well as the underlying goodwill of said intellectual property (collectively, the "Intellectual Property");

AND WHEREAS, Wells Fargo Capital Finance Corporation Canada (formerly Wachovia Capital Finance Corporation (Canada) and Congress Financial Corporation) ("Wells Fargo"), a corporation incorporated under the laws of the Province of Ontario entered into various security agreements with each of the Debtors dated November 12, 2004 and amended by amending agreements dated January 24, 2008 (the "Security Agreements") by which each of the Debtors agreed to grant to Wells Fargo a security interest in the Intellectual Property and other certain property;

AND WHEREAS a Notice of Security Interest was filed against the Intellectual Property with the Canadian Intellectual Property Office and with the United States Patent and Trademark Office;

AND WHEREAS Wells Fargo assigned all if its right, title and interest in and to the Intellectual Property to Salus Capital Partners, LLC (the "Creditor") pursuant to an Assignment Agreement dated January 29, 2013;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Creditor hereby releases and discharges its security interest in the Intellectual Property.


