NOW, THEREFORE, Collateral Agent, without recourse, representation or warranty and at Grantors’ sole cost and expense, hereby TERMINATES all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks and Trademark applications set forth on Schedule I attached hereto; and

FURTHER, Collateral Agent agrees to provide Grantors with any information and additional authorization necessary to effect the termination of Collateral Agent’s security interest in the Trademark Collateral.
