1.1 Assignor hereby assigns, transfers and conveys to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the Marks throughout the world, and all of Assignor's applications and registrations therefor, including but not limited to those identified on the attached **Schedule 1**, together with the goodwill of the business associated therewith, as well as the right to any and all causes of action and rights of recovery for past infringement of the Marks, if any, to be held and enjoyed by Assignee.

2. No Warranties

2.1 Assignor makes no representations or warranties to Assignee regarding validity or non-infringement of the Marks with respect to third parties.


3. Cooperation to Perfect Assignment

4. Recordation of Assignment by Assignee



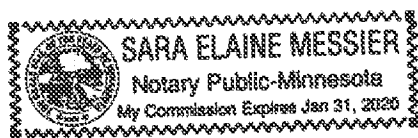
