**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of March 21, 2016 (this "Release") is made by Medley Capital Corporation, acting in its capacity as collateral agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of March 28, 2014 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") between Universal Restoration Services, LLC (the "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at Reel 005361, Frame 0557 on September 12, 2014, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A (the "Trademark Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
