ASSIGNMENT

This Agreement is made and entered into this 28 day of February, 2015 by and between Drink Pie, LLC, a Wisconsin Limited Liability Company with an address at 7839 Twinflower Drive, Madison, Wisconsin 53719 and Travis Hasse (hereinafter collectively "Assignor") and TM Projects, Ltd., an Illinois Corporation with an address at 6 Pheasant Row, Lincolnshire, Illinois 60069 (hereinafter "Assignee").

WHEREAS, Assignor has adopted and is using the SUMMER SHINE trademark shown on Exhibit A attached hereto and made a part hereof in the United States in connection with liqueurs and Assignor is the owner of all right, title and interest in and to U.S. Trademark Registration No. 4,508,022 for the SUMMER SHINE trademark also shown on Exhibit A and all common law rights in said SUMMER SHINE trademark; and

WHEREAS, Assignor desires to assign, and Assignee desires to acquire all right, title and interest in and to the SUMMER SHINE trademark shown on Exhibit A including U.S. Trademark Registration No. 4,508,022 for the SUMMER SHINE trademark also shown on Exhibit A and all common law rights in said SUMMER SHINE trademark together with the goodwill of the business symbolized by the SUMMER SHINE trademark.

NOW THEREFORE, ten thousand dollars (\$10,000.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor has agreed to sell, convey, transfer, assign, and deliver and by these presents does hereby sell, convey, transfer, assign, and deliver unto Assignee, its successors and assigns the entire right, title, and interest in, to, and under U.S. Trademark No. 4,508,022 for the trademark SUMMER SHINE and the trademark SUMMER SHINE shown on Exhibit A attached hereto and made a part hereof, including all common law rights, together with the goodwill of the business symbolized by said SUMMER SHINE trademark registration and trademark, and all rights to sue and recover for any past infringements of said SUMMER SHINE trademark registration and trademark, the same to be held and enjoyed by the said Assignee for its own use and behalf and for its successors and assigns.

Assignor shall, upon the reasonable request of Assignee and at Assignee's expense, execute and deliver such additional documents as may be necessary or convenient for the purpose of evidencing or perfecting any rights or interests arising under this Agreement.

This Agreement fully and completely divests Assignor of any and all right, title and interest in, to and under the aforesaid SUMMER SHINE trademark and the related business. Assignor will not adopt SUMMER SHINE, or any mark similar thereto, in the future.

This Agreement may be signed using one or more counterparts, each of which when signed shall be deemed to be an original and all of which when taken together shall constitute one and the same agreement.




