TERMINATION OF TRADEMARK SECURITY INTEREST

This is a Termination of Trademark Security Interest, dated as of February 23, 2016, executed on behalf of WELLS FARGO BANK, N.A., successor by merger to Wells Fargo Trade Capital, LLC (the "Secured Party") by BANK OF THE WEST (the "New Lender"), releasing all security interests of the Secured Party in the Trademarks (defined below) owned by OLUKAI, LLC, an Oregon limited liability company (the "Debtor") in accordance with authority granted to New Lender pursuant to a Payoff Letter dated January 20, 2014.

2. Revocation of Power of Attorney. Any powers of attorney granted by Debtor to the Secured Party in connection with the grant of security interest in the Trademarks is hereby revoked.

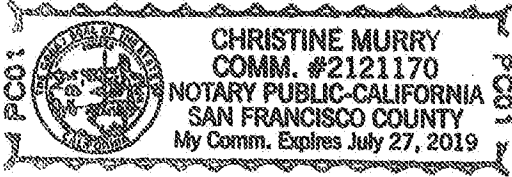
