TRADEMARK ASSIGNMENT

Assignor agrees to execute and/or electronically transmit any and all registration templates, powers of attorney, applications, assignments, declarations, affidavits, and any other papers requested by Assignee to record the transfer to Assignee of the Trademarks.

2. Assignee's Rights. Assignee may use the Trademarks in connection with providing its goods and services and take all actions to enforce its rights in the Trademarks as of the Effective Date.

3. Binding Effect. This Assignment shall be binding upon and shall inure to the benefit of the Parties hereto and their respective successors, permitted assigns, heirs, beneficiaries, and affiliates including partners, officers, directors, parents, and subsidiaries.

4. Governing Law. This Assignment may be executed in one or more counterparts, and shall be governed by, and construed in accordance with, the laws of the State of Maryland.
