SERVICEMARK ASSIGNMENT

This Servicemark Assignment, made and entered into this 31 day of March, 2016, by and between Paul's Auto Yard, Inc., an Indiana Corporation, located at 651 West State Road 2, P.O. Box 50, Westville, Indiana 46391-0050, hereinafter referred to as Paul's Auto Yard; and Bearfoot, Inc., an Indiana Corporation, located at P.O. Box 50, Westville, Indiana 46391, hereinafter referred to as Bearfoot.

WHEREAS, Paul's Auto Yard is the owner of select servicemark rights upon the servicemarks MUD PATROL, Reg. No. 1,892,387, registered on April 17, 2012, CADAVER, Reg. No. 3,540,686, registered on December 2, 2008, and MONSTER PATROL, Reg. No. 1,791,982, registered on September 7, 1993, and desires to assign said registration to Bearfoot; and Bearfoot is desirous of acquiring all of said right, title and interest in and to said servicemarks registrations, as currently held by Paul's Auto Yard.

Therefore, in consideration of the sum of one dollar (\$1.00), paid by Bearfoot to Paul's Auto Yard, the receipt of which is hereby acknowledged Paul's Auto Yard does hereby sell and assign to said Bearfoot all of its right, title and interest in and to said servicemarks registrations upon MUD PATROL No. 1,892,387, CADAVER No. 3,540,686, and MONSTER PATROL No. 1,791,982 the same to be held and enjoyed by Bearfoot to the full end of the terms for which said servicemarks has been registered, as fully and entirely as the same would have been held and enjoyed by Paul's Auto Yard, if this assignment and sale had not been made; the assignment of said servicemark and its registration includes the transfer and assignment of the said servicemarks, its registrations, and the goodwill symbolized by the marks as used upon the identified service in commerce, so that Bearfoot obtains the full and exclusive rights to the statutory servicemarks registrations, and any common law rights incident thereto, pertaining to the servicemarks being assigned herein; and, included in the assignment of the servicemarks, and their registrations, is the right of Bearfoot to initiate and prosecute any suit for servicemark infringement, that may have occurred prior to the date of execution of this assignment, and to recover and

retain any damages sustained as a result of any said infringement or unfair competition perpetrated by others.
