TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT



Additionally, Assignor grants, transfers and assigns to Assignee all right, title and interest in and to the Domain. Within ten (10) days after the execution by both parties of the Assignment, Assignor shall notify the registrar of the Domain of the assignment of the Domain and shall initiate the transfer of the Domain from Assignor's registrar to Assignee's registrar. Assignor agrees to cooperate fully with Assignee to change the identification of the registrant of the Domain to Assignee and in the transfer of the Domain to a registrar of Assignee's choice. Assignee shall be responsible for all filing fees and direct costs associated with the transfer.

3. Further Acts. Assignor agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary for Assignee to perfect and record its interest in the Trademark.

4. Miscellaneous. This Agreement shall (i) be binding on the successors, assigns and licensees of Assignor and Assignee (ii) inure to the benefit of the successors and assigns of Assignee, and (iii) be governed by and construed in accordance with the laws of the State of California.


