## INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (“Assignment”), effective as of May 20, 2013, is entered into by and between World Chess Federation, Inc., a Nevada non-profit corporation (“Assignor”), and Yvette Weinstein, Chapter 7 Trustee of the Bankruptcy Estate of Stan Bryan Vaughan and Tatiana Vaughan (“Assignee”).

### RECITALS

- A. On May 20, 2013, Stan Bryan Vaughan and Tatiana Vaughan (the “Debtors”) commenced their joint bankruptcy case, Case Number 13-14399 (“Case”), by filing a voluntary petition for relief in the United States Bankruptcy Court for the District of Nevada (the “Bankruptcy Court”) under Chapter 7 of Title 11 of the United States Code (“Bankruptcy Code”).
- B. Upon the filing of the Case, the Debtors’ assets became property of the Estate, and thus became subject to Assignee’s control, administration and liquidation, in accordance with the performance of her statutory duties as the Chapter 7 trustee of the Estate.
- C. On January 8, 2015, Assignee filed a complaint initiating an adversary proceeding in the Bankruptcy Court against Assignor, Adversary Proceeding Number 15-01002-GS (the “WCF Litigation”). Through the WCF Litigation, Assignee sought, among other things, the substantive consolidation of Assignor and all of its assets with the Estate, making all assets of Assignor part of the Estate and subject to the Assignee’s control, administration and liquidation in the Case.
- D. On March 16, 2016, the Bankruptcy Court entered its *Findings of Fact, Conclusions of Law, and Order Granting Supplemental Default Judgment Against Defendant World Chess Federation, Inc.* in Adversary Proceeding Number 15-01002-GS [Adversary Docket No. 102], attached as Exhibit A hereto (the “Judgment”) against Assignor, which, among other things, substantively consolidated Assignor with the Estate, *nunc pro tunc* to the filing date of the Case, and made all assets and property of Assignor part of the Estate, subject to administration and sale by Seller with the oversight of the Bankruptcy Court. The Judgment further authorizes Assignee, among other things, to transfer, record, or register any assets, interests, or property of Assignor in her own name or in the name of the Debtors’ Estate, as she may deem appropriate, and further directs all third parties and agencies involved in any such transfers, recordations, or registrations to recognize and accept any and all transfers, recordations or other filings made by Assignee in accordance with the Order, whether in Assignee’s name, Assignor’s name, or otherwise.
- E. Assignee, as Chapter 7 Trustee of the Debtors’ Estate, desires to confirm the terms of the Judgment, including Assignee’s acquisition of all of Assignor’s right, title and interest in, to and under the intellectual property conveyed pursuant thereto, including without limitation the intellectual property identified in Schedule A attached hereto (the “IP Assets”).
