C. §§ 18-101, et seq. (the "**Act**").

1. The Company was originally formed as a Connecticut corporation under the name "Stancor, Inc." by the filing of its Certificate of Incorporation with the Secretary of State of the State of Connecticut on January 31, 1985, and the jurisdiction of the Company immediately prior to its conversion was the State of Connecticut.

2. The Company's name immediately prior to filing this Certificate was "Stancor, Inc."

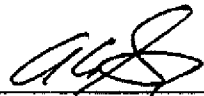
