## TERMINATION OF SUPPLEMENTAL SECURITY AGREEMENT

This Termination of Supplemental Security Agreement (this "Trademark Termination"), dated as of May 10, 2016, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Lender"), in favor of EMPIRICAL GROUP, LLC, a Delaware limited liability company (the "Borrower").

### RECITALS

**WHEREAS**, the Borrower and the Lender entered into that certain Credit Agreement (the "Credit Agreement"), dated as of September 19, 2002;

**WHEREAS**, in connection with the Credit Agreement, the Borrower and the Lender entered into that certain Supplemental Security Agreement (the "Supplemental Trademark Agreement"), dated as of September 19, 2002;

**WHEREAS**, the Supplemental Trademark Agreement was recorded with the United States Patent and Trademark Office on March 24, 2003 at Reel 002622, Frame 0255;

**WHEREAS**, pursuant to the Supplemental Trademark Agreement, the Borrower granted to the Lender a security interest in certain "Collateral" (as defined in the Supplemental Trademark Agreement) including certain registered trademarks; and

**WHEREAS**, the Supplemental Trademark Agreement has been terminated.

**NOW, THEREFORE**, Lender agrees as follows:

1. Lender is executing and delivering this Trademark Termination as further evidence of the termination of the Supplemental Trademark Agreement.



Lender claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Supplemental Trademark Agreement, and, accordingly, Lender expressly terminates, releases, and discharges any and all security interests that it has pursuant to the Supplemental Trademark Agreement in any and all right, title and interest of the Borrower and reassigns to the Borrower any and all right title and interest that it may have in, to and under (i) the trademarks listed on Exhibit A hereto and (ii) all products and proceeds of the foregoing, including any claim by the Borrower against third parties for past, present or future infringement of the foregoing.

3. This Trademark Termination is governed by the laws set forth in Section 10(g) (Governing Law) of the Credit Agreement.
