TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Assignment") is made, entered into, and effective as of this 13th day of May, 2016 (the "Effective Date"), by and between ARLINGTON PARK RACECOURSE, LLC ("Assignor"), an Illinois limited liability company with an address of 2000 W. Euclid Avenue, Arlington Heights, Illinois 60007, and CHURCHILL DOWNS INCORPORATED ("Assignee"), a Kentucky corporation with an address of 600 N. Hurstbourne Parkway, Suite 400, Louisville, KY 40222.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained in this Assignment, and for other good and valuable consideration, Assignor and Assignee hereby agree as follows:

1. **ASSIGNMENT.** Assignor hereby transfers and assigns to Assignee, and Assignee hereby accepts from Assignor: (a) the service mark **INTERNATIONAL FESTIVAL OF RACING** (the "Mark"), (b) all registrations for the Mark, including, without limitation, U.S. Reg. No. 1,980,602; (c) all rights, title, and interest in and to the Mark, including, without limitation, trademark and service mark rights, the rights to bring and maintain any and all causes of action, claims, and demands for infringement or other violations of rights, and the rights to pursue all remedies therefor (including those incurred prior to the date of this conveyance); and (d) all goodwill associated with and symbolized by the Mark.

2. **COVENANT.** Assignor covenants that Assignor has the right to enter into this Assignment and further agrees, without further consideration, to cause such other lawful acts to be performed and such further assignments and other lawful documents to be executed, as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and record owner of each of the rights hereby conveyed.

3. **GOVERNING LAW.** This Assignment, and any subsequent amendments or modifications to this Assignment, shall be governed by and construed in accordance with the laws of the Commonwealth of Kentucky, without regard to its or any other jurisdiction's conflict of laws rules or principles.
