RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this [z] day of May 2016, by Frost Bank, successor-by-merger to Summit Bank, N.A., whose address is 100 W. Houston St., San Antonio, TX 78205 ("Secured Party").

WHEREAS, reference is made to a certain Security Agreement dated as of June 16, 2005, by and between Pfab LP, a Texas limited partnership now known as Neos Therapeutics, LP (the "Debtor"), whose address is 2940 N. Further, Secured Party understands and agrees that this Release may be recorded by or for Debtor with the USPTO, United States Copyright Office and any other similar office or agency throughout the world.

Secured Party, at no cost or expense to Secured Party, also agrees to execute any other documents and take any further action in any jurisdiction that Debtor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflict of laws principles. This Release may be executed by one or more of the parties to this Release on any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
