CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, Patholase, Inc., a California corporation, (“Assignor”) filed a U.S. application for the mark PINPOINTE, which has since registered, Reg. No. 3,803,945 (the “Mark”);

WHEREAS, on August 13, 2009, Assignor changed its name to Pinpointe U.S.A., Inc.;

WHEREAS, on September 7, 2011, Assignor transferred the Mark and associated goodwill to Nuvolase, Inc., a Delaware corporation, as part of a larger Asset Purchase and Stock Exchange Agreement;

WHEREAS, on October 31, 2011, Assignor changed its name back to Patholase, Inc.;

NOW, THEREFORE, Assignor hereby reaffirms and confirms that by virtue of the September 7, 2011 Asset Purchase and Stock Exchange Agreement, Assignor assigned and transferred, and does hereby affirm that it did assign and transfer the entire right, title, and interest in and to the Mark, together with the associated goodwill, all common law rights, the above-referenced Mark, and the right to register, renew, protect and defend said Mark and to sue for past infringements of said Mark;
