Termination of Grant of Security Interest in United States Trademarks

This Termination of Grant of Security Interest in United States Trademarks (this "**Termination**"), dated as of May 27, 2016, is executed by Commonwealth Bank of Australia ("**Grantee**"), in favor of Gale Pacific USA, Inc., a corporation incorporated under the laws of the State of Florida (the "**Grantor**").

RECITALS

WHEREAS, the Grantor and the Grantee entered into that certain Grant of Security Interest in United States Trademarks (the "**IP Security Agreement**"), dated as of May 2, 2012;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on May 3, 2012 at Reel 4772, Frame 0294;

WHEREAS, pursuant to the IP Security Agreement, the Grantor granted to Grantee a security interest in certain "Marks" (as defined in the IP Security Agreement) including certain registered trademarks; and

WHEREAS, the IP Security Agreement has been terminated pursuant to a certain Deed Poll of Release dated May 27, 2016 between the parties listed therein, including the Grantor and Grantee.


NOW, THEREFORE, Grantee agrees as follows:

1. The Grantee is executing and delivering this Termination as further evidence of the termination of the IP Security Agreement.
2. The Grantee claims no right, title or interest whatsoever in or to any of the "Marks" described in the IP Security Agreement, and, accordingly, the Grantee expressly terminates, releases, and discharges any and all security interests that it has pursuant to the IP Security Agreement in any and all right, title and interest of the Grantor and reassigns to the Grantor any and all right title and interest that it may have in, to and under (i) the trademarks listed as Exhibit A hereto and (ii) all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of the foregoing.
3. This Termination is governed by the laws set forth in Section 10.6 (Governing Law; Submission to Jurisdiction; Venue; Waiver of Jury Trial) of that certain Security Agreement dated as of May 2, 2012, terms of which are incorporated by reference in the IP Security Agreement.
