
TRADEMARK ASSIGNMENT

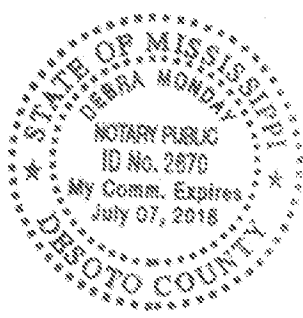


