INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the "Agreement") is made and delivered as of March 31, 2016 (the "Closing Date"), by 2100 FREEDOM, INC., a Delaware corporation ("Freedom") and the subsidiaries of Freedom set forth on Schedule A (the "Subsidiaries" and together with Freedom, the "Assignors") to the Purchase Agreement (as defined below) for the benefit of CALIFORNIA NEWSPAPERS PARTNERSHIP, a Delaware general partnership ("Assignee"). All capitalized terms used herein but not otherwise defined shall have the meanings given them in the Purchase Agreement (as defined below).

WHEREAS, Assignors and MEDIANEWS GROUP, INC., d/b/a/ Digital First Media, a Delaware corporation ("Buyer") are parties to that certain Asset Purchase Agreement (as amended, the "Purchase Agreement") dated as of March 13, 2016, pursuant to which Assignee has agreed to purchase from Assignors the Purchased Assets;

WHEREAS, in accordance with the Purchase Agreement, Buyer has assigned certain of its rights to Assignee;

WHEREAS, Assignors have agreed to transfer, contribute and assign to Assignee all of Assignors' right, title and interest in, to, and under each the Intellectual Property Assets and the Intellectual Property Licenses, including without limitation the Intellectual Property Assets set forth on **Exhibit 1** attached hereto (the "Assigned Intellectual Property Rights"), as more specifically set forth in the Purchase Agreement; and

WHEREAS, pursuant to the Purchase Agreement, Assignors have agreed to assign the Assigned Intellectual Property Rights, and all rights therein to Assignee.

NOW THEREFORE, in consideration of the covenants and obligations recited herein, and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors agree as follows:

AGREEMENT

1. Assignors irrevocably assign to the Assignee, effective from the Closing Date: (i) all of Assignors' right, title, and interest in and to the Assigned Intellectual Property Rights, together with the goodwill associated therewith; (ii) any and all legal actions and rights and remedies at law or in equity for past infringements, misappropriations, or other violations of the Assigned Intellectual Property Rights, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith; and (iii) any and all income, royalties, and payments accruing on or after the Closing Date with respect to the Assigned Intellectual Property Rights, for the Assignee's own use and enjoyment and for the use and enjoyment of the Assignee's successors, assigns, or other legal representatives.

2. Effective from the Closing Date, Assignors agree not to use (and to terminate and discontinue all use of) the terms contained in the Intellectual Property and any terms similar thereto in any domain name, domain name registration, trademark, service mark, trade name, company name, legal name, fictitious business name, logo, and any other indicator of origin, with regard to themselves and any business or entity at any time owned or controlled by Assignors.

3. Assignors authorize and request the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership

in trademark registrations and applications for registration of trademarks, to record the Assignee as the assignee and owner of any and all of Assignors' rights in the Intellectual Property, as applicable.

4. All of the terms and provisions of this Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

5. The terms of the Purchase Agreement, including but not limited to Assignors' representations, warranties, covenants, agreements and indemnities (subject to the limitations therein) relating to the Purchased Assets, are incorporated herein by this reference. Assignors acknowledge and agree that the representations, warranties, covenants, agreements and indemnities (subject to the limitations therein) contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

6. Assignors covenant and agree to execute and deliver, at the request of the Assignee, such further instruments of transfer and assignment and to take such other action as Assignee may reasonably request to more effectively consummate the assignments contemplated by this Agreement.

7. This Agreement and the legal relations between the parties shall be governed by and construed in accordance with the laws of the State of California applicable to contracts made and performed in such State and without regard to conflicts of law doctrines.


