Two Bit Circus, Inc., a Delaware corporation (the "*Company*"), does hereby certify to the following facts relating to the merger (the "*Merger*") of Two Bit Circus, LLC and Two Bit Circus Holdings, LLC (together, the "*LLCs*"), each a Delaware limited liability company, with and into the Company, with the Company continuing as the surviving corporation of the Merger (the "*Surviving Corporation*");

- FIRST: The Company and the LLCs are the constituent corporations in the Merger. The Company is incorporated in Delaware pursuant to the General Corporation Law of the State of Delaware, as amended ("*DGCL*"), and the LLCs are organized in Delaware pursuant to the Delaware Limited Liability Company Act, as amended.

- THIRD: The surviving corporation of the Merger shall be Two Bit Circus, Inc., whose name shall remain Two Bit Circus, Inc.
- FOURTH: Upon the effectiveness of the Merger, the certificate of incorporation of the Company shall be the certificate of incorporation of the Surviving Corporation.
- FIFTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Corporation at 678 S. Avenue 21, Los Angeles, California, 90031.
- SIXTH: A copy of the executed Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of the constituent corporation of the Merger or member of any constituent limited liability company.
- SEVENTH: The Merger shall become effective upon filing of this Certificate of Merger with the Delaware Secretary of State.
