**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of June 29, 2016, is made by FIFTH THIRD BANK, an Ohio banking corporation ("Lender"), under that certain Grant of Security Interest in United States Trademarks, made as of February 26, 2010, by YDESIGN GROUP, LLC (formerly YLighting Acquisition, LLC), a Delaware limited liability company ("Borrower"), in favor of the Lender (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement").

**WHEREAS**, pursuant to the IP Security Agreement, the Borrower granted a security interest to the Lender in certain intellectual property collateral including the Trademarks set forth on Schedule A thereto (the "IP Collateral"); and

**WHEREAS**, an executed copy of the IP Security Agreement was recorded with the (i) Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on March 4, 2010 at Reel 4160, Frame 0675; and


**WHEREAS**, the Lender has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule 1 attached hereto, being the same Trademarks set forth on Schedule A to the IP Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the IP Collateral.
